- An inquiry regarding whether staff serving liquor at the 11th hole tee box kiosk will have proper training such as Serving It Right
- An inquiry regarding the format of liquor license application reports to Council

- Forward the Report entitled "Application for a Permanent Change to a Liquor License for a Liquor Primary Establishment - Rogues Bar & Grill (PROJ 22-113)", dated January 24, 2023, to the Liquor and Cannabis Regulation Branch (LCRB) to serve as Council's comments on the application, as prescribed under the Liquor Control and Licensing Act.
