The Officer-in-Charge Coquitlam RCMP provided an on-screen presentation entitled "RCMP 2020 First Trimester Report: City of Coquitlam" and referred to slides titled as follows:

- Whether it is possible to compare the crime statistics on a year to year basis
- The belief that the community wants to see the trends with respect to crime statistics
- The online crime reporting system recently implemented by the RCMP and its current level of use by the community
- The desire for individuals that are reporting crimes to do so through the online reporting system rather than non-official channels
- The belief that the RCMP are serving the community well and expressions of support for RCMP
- The belief that there is a relationship between large roadways and the number of thefts that occur around them
- The desire for more social supports outside of policing
- The ability of the RCMP to liaise with city staff to offer social supports prior to RCMP involvement in a response
- The response of the RCMP Commissioner to the allegations of systemic racism within the RCMP
- The response of the Coquitlam RCMP relative to the allegations of systemic racism within the RCMP
- The belief that all people have biases and the desire to recognize them
- Whether the RCMP receive the data held by the Province regarding incidents of hate speech

The Officer-in-Charge undertook to review whether hate speech data from the Province is provided to the Coquitlam RCMP.

- The belief that a better understanding of the RCMP and their response to hate speech would make the community more welcoming
- Appreciation that distracted driving and seatbelt offences were down
- The desire to understand why intoxicated driving offences had increased
- Conversations with RCMP members and the belief that they are considering their role as police officers given events occurring around the world
- Whether the defund the police movement was the appropriate response to social issues
- The role of police with respect to mental health and the desire to look at a health based response to mental health crises
- The number of mental health calls responded to by the RCMP and the impacts of COVID-19 on the number of calls received
- The levels of family violence calls responded to by the RCMP and the impacts of COVID-19 on the number of calls received
- Appreciation for speed enforcement measures taken by the RCMP
- The effectiveness of hate crimes legislation in Canada and how the City could

support efforts to make it more effective

- The belief that it is the role of leaders to consider their role as police officers and communicate that to their subordinates
- Whether there has been an increase in anti-Asian racism
- Whether the online crime reporting system was available for use in reporting incidents of racism
- Appreciation for the efforts of the RCMP to educate new Canadians regarding the role of the RCMP
- The role of the RCMP's mental health officers relative to other RCMP officers
- The desire for more resources to be directed towards to those with mental health challenges
- The belief that RCMP officers are under additional stress due to the rise of the defund the police movement
- Support for the increased levels of traffic enforcement over the last trimester
- The desire to follow the trends in traffic behaviours and how those trends can be tracked
- The belief that residents want to see police officers in the community.
- The use of the hate crimes telephone line by the community
- The Car 87 program that is in use in other communities
- The trends in distracted driving infractions

ENGINEERING AND PUBLIC WORKS

7. Report of the General Manager Engineering and Public Works – 2019 Urban Wildlife Program Update and 2020 Early Cart Set Out Audit Results

The General Manager Engineering and Public Works provided comments regarding the number of wildlife encounters in Coquitlam and the measures that the public can undertake to reduce them. He noted the evaluations that staff have performed on the initiatives implemented by the City to reduce wildlife encounters.

Discussion ensued relative to the following:

- The number of warnings issued relative to the number of tickets issued for garbage cart violations
- The desire to fine repeat garbage cart offenders and to change behaviours with respect to wildlife attractants
- Clarification of the types of reports received with respect to bears
- Whether bear sighting data that is reported to the BC Conservation Officer

Service is provided to the City

- The understanding that there are bears in areas across the city that may not be reported to the City
- The belief that there are fewer garbage containers being placed on the curb too early in the day
- Whether the use of bear bangers is increasing in the community

The Committee received the report of the General Manager Engineering and Public Works dated June 15, 2020 and entitled "2019 Urban Wildlife Program Update and 2020 Early Cart Set Out Audit Results" for information.

8. Report of the General Manager Engineering and Public Works –2019 Annual Drinking Water Quality Report

The General Manager Engineering and Public Works provided comments regarding the purpose of the report, how water quality is assessed and noted some of the changes in the report from the previous year. He also provided information on the factors that can impact water quality. He noted that the full report is available on the city's website.

Discussion ensued relative to the following:

- Concerns regarding the message from the Medical Health Officer with respect to lead and copper in the water supply
- The belief that it is not necessary to run the tap for one minute in Coquitlam and many other communities in the Lower Mainland
- Whether people are using more water due to the pandemic
