- The understanding that as the City grows, existing views will change due to development
- The understanding that the development plan includes bike parking

Appreciation for improving the tenant relocation package

- Appreciation for the applicant's inclusion of rental and low-income units as part of their projects in Coquitlam and for taking advantage of incentives to build lowincome housing
- The desire for residents concerned about development to undertake their own due diligence in keeping informed about proposed changes
- The understanding that the City utilizes a wide variety of notification methods to inform residents of any potential changes to the *Zoning Bylaw* and the *Official Community Plan*
- The understanding that there are challenges in trying to notify every single resident of each development plan
- The sharing of knowledge about the "Notify me" function on the Coquitlam website which can be used to register to receive information directly via e-mail
- The desire for strata councils to designate an individual to subscribe to development notifications
- The desire to find ways to make the process more engaging
- The recognition of the need for low income rental housing
- The desire for more demographic information to identify gaps in housing needs
- The understanding that Public Hearings are focused on the land use of applications
