QUESTIONS AND CLARIFICATIONS

- Q1. Can the submission deadline be extended until 31 Oct?
- A1. At this point in time the City will extend the deadline by two (2) days, see R1.
- Q2. For construction phase, as the design is not yet determined, the required services during construction could vary significantly depending upon the final design. For the services during construction, instead of lump sum, would the City accept hourly rates and per site visit estimate?
- A2. Proponent to provide a cost of Services, along with hourly rates and per site visit costs for any changes to the Services that are authorized by the owner.

- Q3. On point 3.8 Fee Schedule and Cost of Services, to clarify, the lump sums requested are the summation of the hourly rates and level of effort required by the overall suggested project team in each phase (i.e. not fixed fee)?
- A3. See Clause 26 of the Consulting and Professional Service Agreement for changes to the Scope of services.
- Q4. Is it correct to understand that the City of Coquitlam is not seeking a fixed fee?
- A4. The City is seeking a fixed fee for the Services.
- Q5. On 3.8d), it is anticipated that if there are changes in work order or schedules, there could be additional costs incurred. Can the City of Coquitlam clarify that no additional costs will be allowed if there are changes in the project scope, work order or schedule? Can the City remove Item 3.8 d)?
- A5. See Clause 26 of the Consulting and Professional Service Agreement
- Q6. It is mentioned that the excavation required is 6.5M to 10M. However, it seems that only 1 level of parking is underground. Can the City confirm the number of anticipated underground levels and confirm the anticipated depth of excavation to construction the underground levels?
- A6. Two levels of underground parking are contemplated with a varying depth of 6.5m to 10.0m due to the topography of the mountain slope site conditions.
