DEFINITIONS

"Agreement" "Contract" means the contract for services or City Purchase Order that will be issued to formalize with the successful Proponent through negotiation process with the City based on the proposal submitted and will incorporate by reference the Request for Proposals, Specifications, Drawings, any additional subsequent information, any addenda issued, the Proponent's response and acceptance by the City.

"City" "Owner" means City of Coquitlam;

"Contractor" means the person(s) firm(s) or corporation(s) appointed by the City to carry out all duties, obligations, work and services described in the Request for Proposal and all associated documentation, which may also include mutually agreed revisions subsequent to submission of a Proposal. Both "Contractor" and "Proponent" are complementary in terms of duties, obligations and responsibilities contemplated at the Request for Proposals stage, through evaluation process, execution and performance of the services and Works.

"Price" means the amount that will be paid by the City to the Contractor for delivery and acceptance of goods and Services;

"Project Manager" means the City staff member appointed to coordinate the Work;

"Proponent" means responder to this Request for Proposals;

"Proposal" means the submission by the Proponent;

"Request for Proposals" "RFP" shall mean and include the complete set of documents, specifications and addenda incorporated herein, and included in this Request for Proposals;

"Services" "Work" "Works" means and includes the provision by the successful Proponent of all services, duties, and expectations as further described in this RFP. This will also mean the whole of the Work, tools, materials, labour, equipment, travel, and all that is required to be done, furnished and performed by the Contractor;

"Shall" "Must" "Will" "Mandatory" means a requirement that must be met;

"Supply" "Provide" shall mean supply and pay for and provide and pay for.

1. INSTRUCTIONS TO PROPONENTS

1.1. <u>Acknowledgement</u>

The City acknowledges with gratitude and respect that the name Coquitlam was derived from the həṅqəmiṅəṁ (HUN-kuh-MEE-num) word kʷikʷəẋəm (kwee-KWET-lum) meaning "Red Fish Up the River". The City is honoured to be located on the kʷikʷəẋəm traditional and ancestral lands, including those parts that were historically shared with the qićəý (kat-zee), and other Coast Salish Peoples.

1.2. Purpose

The purpose of this RFP is to invite Proposals from qualified firms for the supply, delivery and installation of **Mariner Fire Station Overhead Doors Replacement** as specified within this RFP document.

1.3. Proposal Submission

Proponents should complete and submit the information requested in this RFP document on the Proposal Submission Form or in a format that has been approved and is acceptable to the City.

1.4. <u>Instructions to Proponents</u>

Proponents are advised that the rules for participation that will apply to this RFP are located: <u>Instructions to Proponents.</u>

By submission of a Proposal in response to this RFP, the Proponent agrees and accepts the rules by which the bid process will be conducted.

1.5. Prices

Prices shall be all-inclusive and stated in (Canadian Funds). Prices shall remain FIRM for the completion of the Services.

Prices shall include the provision of all tools, materials, equipment, labour, transportation, fuel, supervision, management, overhead, materials, traffic control, services, all necessary packing and crating (where applicable), Canadian Customs import and export duties, freight, handling, insurance, all other associated or related charges, foreign, federal, provincial and municipal taxes, bonding costs, all licences, permits, inspections and all other requirements necessary for the commencement, performance and completion of Services as described.

Taxes are to be shown separately at time of invoicing.

The lowest price of any Proposal will not necessarily be accepted but will be analyzed to determine best overall value.

1.6. Requested Departures

The Proponent acknowledges that the departures requested in the Proposal Submission Form will not form part of the Contract unless and until the City specifically

consents in writing to any of them. The City may not consider any departures not stated in the Proponent's Proposal Submission.

1.7. Evaluation Criteria

The City uses Microsoft Word to aid the transfer of Proponents information to an evaluation document. Proposal Submission Form responses should provide direct answers or a concise summary of attachments. If attachments are required, ensure to provide a summary for each question then direct the City to the appropriate section within the attachments.

Lower scores may be recorded if Proposal Submission Forms are:

- Not in Microsoft Word
- Only answering questions with "see section x in attached document".

These criteria will be used to determine best overall value to the City. Proposals will be compared to select one or more that are most advantageous.

And, upon selection of one or more lead Proponent(s):

- References may be contacted
- Interviews may be conducted

The City reserves the right to check references on other projects even if they are not specifically listed. Information obtained from references will be confidential and will not be disclosed to any Proponents.

These criteria will be used to determine best overall value to the City as well as any other criteria that may become evident during the evaluation process.

The City may, at its discretion, request clarification or additional information from a Proponent with respect to any Proposal and the City may make such requests to only selected Proponents. The City may consider such clarifications or additional information in evaluating a Proposal.

Incomplete Proposals or Proposals submitted on forms other than the Proposal Form may be rejected.

Proponents agree the City may disclose names of Proponents and total award amount, however, unevaluated results, unit prices, rates or scores will not be provided to any Proponents.

The City reserves the right to reject without further consideration any Proposal which in its opinion does not meet the criteria it considers essential for the Work outlined in this RFP.

Where only one Proposal is received, the City may reject such and re-issue the RFP on a selected basis.

1.8. Eligibility

For eligibility, and as a condition of award, the successful Proponent would be required to meet or provide the equivalent:

- a) Commercial General Liability (CGL) insurance \$5M coverage provided on the <u>City's Standard Insurance Form</u>
- b) <u>Prime Contractor Designation Form</u> and be responsible for all the Work at the site in accordance with WCB regulations
- c) Be registered and provide WorkSafeBC clearance

- d) Accept the City's standard Terms and Conditions posted on the City's website: Standard Terms and Conditions - Purchase of Goods and Services
- e) A City of Coquitlam or Tri Cities Intermunicipal <u>Business License</u>

These items are not required as part of this Proposal Submission but will be required prior to entering into an agreement with the City for Services.

1.9. Project Timeline

Estimated timelines for the project are:

Earliest Construction Start: May 5, 2025

Final Completion: September 5, 2025

Upon award, the Work on this project shall progress until fully completed.

1.10. Specifications and Alternatives

Wherever the Specifications state a brand name, make, name or manufacturer, trade name, or Supplier catalogue number, it is for the purpose of establishing a grade or standard. It is not intended to rule out competition from equal brands or makes. If goods other than that specified is offered, it is the Proponent's responsibility to provide information in its Proposal that enables the City to confirm equivalency and acceptance.

If the Proponent cannot meet Specifications, the Proponent may identify and offer an alternative which it believes to be an equal or better alternative.

Proponents shall clearly indicate any variances from the City's Specifications or conditions and attach descriptive literature

2. GENERAL CONDITIONS OF CONTRACT

2.1. Terms and Conditions of Contract

The City's <u>Standard Terms and Conditions - Purchase of Goods and Services</u>, as published on the City's website, the Conditions listed in this RFP, along with the accepted Proposal, addenda and any subsequent clarifications, correspondence, the totality of which will constitute the Contract.

3. SCOPE OF SERVICES

3.1. Overview:

The City is requesting Proposals for the replacement of overhead doors at the Mariner Fire Station, constructed in 1991. This project includes the removal of existing overhead doors, supply of new doors, installation of new overhead doors, and any necessary structural, mechanical, and electrical modifications to accommodate the new doors.

3.2. Scope of Work

The work includes but not limited to:

a) Project Planning:

- Conduct a site assessment to verify dimensions and existing conditions of the overhead doors.
- Ensure compliance with all local building codes, regulations, and fire safety requirements.
- Coordinate a phased approach to ensure that three (3) of the four (4) doors are operational at all times.

b) Quantity

• Total of four (4) overhead doors to be replaced (West elevation facing Mariner Way).

c) Removal of Existing Overhead Doors:

- Dismantle and remove existing overhead doors, frames, and associated components.
- Prioritize recycling such as metals, electrical components, and other recyclable materials. The Contractor must ensure that all recyclable materials are handled and processed in compliance with applicable environmental laws and regulations.
- Dispose of any non-recyclable materials in compliance with local bylaws.
- Inspect and document the condition of the structural opening to ensure it is suitable for the installation of new doors.

d) Overhead Doors:

- Supply and install new overhead doors that meet the fire station's operational requirements, including high durability, reliability, and safety features (e.g., rapid opening/closing mechanisms, thermal insulation, and weatherproofing).
- New doors must meet or exceed current opening/closing operating time.
- Ensure that the new doors are compatible with the fire station's existing or updated electrical and control systems.
- Provide necessary structural adjustments to the door frames and openings, if required.
- Reinstall vinyl numbers on interior of overhead doors to label Bays 1-4.
- Amarr 2742 c/w GDI Electric Operators with cycle counter and soft start/stop.
- Pre-approved equivalent will be considered.

e) Mechanical and Electrical Upgrades:

 If required upgrade or modify electrical systems to accommodate the new overhead door motors and control systems, including wiring, control switches, sensors, and power supplies.

- Integrate safety systems such as auto-reverse mechanisms, motion detectors, and manual override systems.
- Provide all necessary mechanical work, including the installation of door tracks, tension springs, and other hardware to ensure smooth and safe operation.

f) Testing and Commissioning:

- Provide Site Acceptable Test (SAT) and final sign-off.
- Perform comprehensive testing of all installed doors, including operation speed (inches per second), safety features, and emergency manual override functions.
- Ensure that all mechanical and electrical components operate within the manufacturer's specifications.
- Provide on-site training for fire station personnel on the proper operation, maintenance, and emergency procedures related to the new doors.
- Supply warranty and operation manual documentation, including the make/model/serial number per door.

3.3. Active Fire Hall Operations

The Contractor acknowledges that the Work site is located within an active fire hall, and that fire department operations will take priority at all times. The Contractor must ensure that all personnel, equipment, and vehicles are prepared to relocate or cease Work immediately upon request by fire department staff.

The Contractor shall, without delay, move any equipment or personnel from designated access routes and ensure clear and unobstructed passage for fire department vehicles and personnel responding to emergencies. Coordination with fire hall staff will be required to minimize disruptions, and all Work shall be performed in a manner that ensures the continuous operation of the fire hall.

In the event of an emergency, the Contractor may be required to demobilize until a later date.

3.4. Site Acceptance Test

Upon completion of equipment installation, the Contractor is required to test the system to ensure it complies with the manufacturer's specifications. The Contractor must provide evidence that the equipment starts up correctly and meets the specified requirements under normal operational conditions, and that it will continue to do so consistently.

3.5. <u>Clean Up</u>

At the end of each day the Contractor shall ensure the site is safe and secure and, at the conclusion of Work, the Contractor shall clean out all debris promptly remove any equipment or materials and leave the site of the Work in a clean and tidy condition.
