Notice of Zoning Amendment Bylaw for First, Second and Third Readings – 435, 439, 455, 465 North Road and 500 Austin Avenue – Bylaw No. 5418, 2025

Notice is hereby given that the City of Coquitlam has received an application to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* relating to the properties located at 435, 439, 455, 465 North Road and 500 Austin Avenue. The amending Bylaw (No. 5418, 2025) will be presented for first, second and third readings at the Regular Council Meeting on January 13, 2025 at 7:00 p.m. in the Council Chambers of City Hall, located at 3000 Guildford Way, Coquitlam, BC.

The intent of *Bylaw No. 5418, 2025* is to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* to rezone the subject properties, as outlined in black on the map marked "Schedule 'A' to Bylaw No. 5418, 2025", from C-2 General Commercial to CD-48 Comprehensive Development Zone - 48.

If approved, the application would facilitate the creation of a master planned high density mixed-use development consisting of six towers in four phases that includes residential, retail space, two child care facilities and a publicly accessible plaza.

Following the enactment of the provincial *Bill 44 – 2023 Housing Statues (Residential Development) Amendment Act*, public hearings are prohibited for rezoning applications that are consistent with the Official Community Plan (OCP), amendments to the Zoning Bylaw that facilitate small scale multiple unit housing and for mixed-use projects that are consistent with the OCP, where at least half of the proposed gross floor area is residential.

The Bill is applicable to any rezoning application that has not received first reading prior to November 30, 2023. For these applications, Council may grant first, second and third bylaw readings and adopt the bylaw (if no pre-requisites are required to be met prior to the adoption) at same Regular Council Meeting.

The City of Coquitlam is required to provide public notification prior to first reading of the bylaw in accordance with the *Local Government Act*, as follows:

- Mail out or delivery of notice to the owners and tenants of the properties that are the subject of the rezoning and the properties within 100m of the development site, not less than 10 days prior to first reading of the bylaw; and
- Publication of notice pursuant to *Public Notice Bylaw No. 5334, 2023* (on the City's website and through the City's email subscription service), not less than seven days prior to first reading of the bylaw.


