## Notice of Zoning Amendment Bylaw for First, Second and Third Readings – 606, 608, 610A, 610B, 612, and 612A Thompson Avenue -Bylaw No. 5412, 2025

Notice is hereby given that the City of Coquitlam has received an application to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* relating to the properties located – 606, 608, 610A, 610B, 612, and 612A Thompson Avenue.

The amending Bylaw (No. 5412, 2025) will be presented for first, second and third readings at the Regular Council Meeting on **Monday, March 31, 2025** at 7:00 p.m. in the Council Chambers of City Hall, located at 3000 Guildford Way, Coquitlam, BC.

The intent of **Bylaw No. 5412, 2025** is to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* to rezone portions of the subject properties as outlined in black on the map marked "Schedule 'A' to Bylaw No. 5412, 2025" from RS-1 One-Family Residential to RM-2 Three-Storey Medium Density Apartment Residential.

If approved, the application would facilitate the creation of a townhouse development with 77 market units within five buildings, consisting of 1-bedroom, 1-bedroom plus den, 2-bedroom, 3-bedroom and 3-bedroom plus den unit types.
