QUESTIONS

- Q1. Can the City disclose the assumed budget for the project?
- A1. Anticipated construction costs \leq \$350k.
- Q2. In the RFP, item 6.2 c) is titled 'Preliminary Design and Costing (30%)'. Do you want a Class D costing at this stage alongside the Class C, B & A costings that occur in later stages?
- A2. Yes.
- Q3. Can the City share existing mechanical & electrical drawings for the field house?
- A3. Yes, this will be available for reference to the successful Proponent.
- Q4. Does the city expect heating, ventilation & cooling, or only heating & ventilation for the new space?
- A4. Scope of Work includes: heating, ventilation and cooling
- Q5. Is the existing building heated only? Or heated and cooled? If so, is it electric or gas heat? How is it cooled?
- A5. There is an electric furnace that services office and ticket booth as part of the HVAC system.
- Q6. Unfortunately, we missed the site visit for the Hub at Town Centre Park. Would it be possible to arrange an alternative date for the visit?
- A6. No. other date and time will be offered.
- Q7. Contractor for security/FOB access? Who currently services this building?
- A7. Security contractor installation to be completed by Rose Security. Electrical Consultant to include installation requirements as part of Scope of Work.
- Q8. Accessibility? Door hardware, door sizes?
- A8. Accessibility is not required for this space.
- Q9. Boiler / Hot Water tank location?
- A9. There is a tankless water heater that services domestic water. The tankless water heater is located Mechanical Room #3 (Attic Space).
- Q10. Is a permit required for this project?
- A10. Yes, a tenant improvement project is required to be coordinated through the Coordinated Professional for this project.
- Q11. Are there as-built drawings of the existing building? Are you able to let us know what discipline (IE Architectural, Structural, etc.)? Will these as-built drawings be provided to the successful proponent?
- A11. Yes, as-builts in PDF format will be provided for reference to the successful Proponent.
